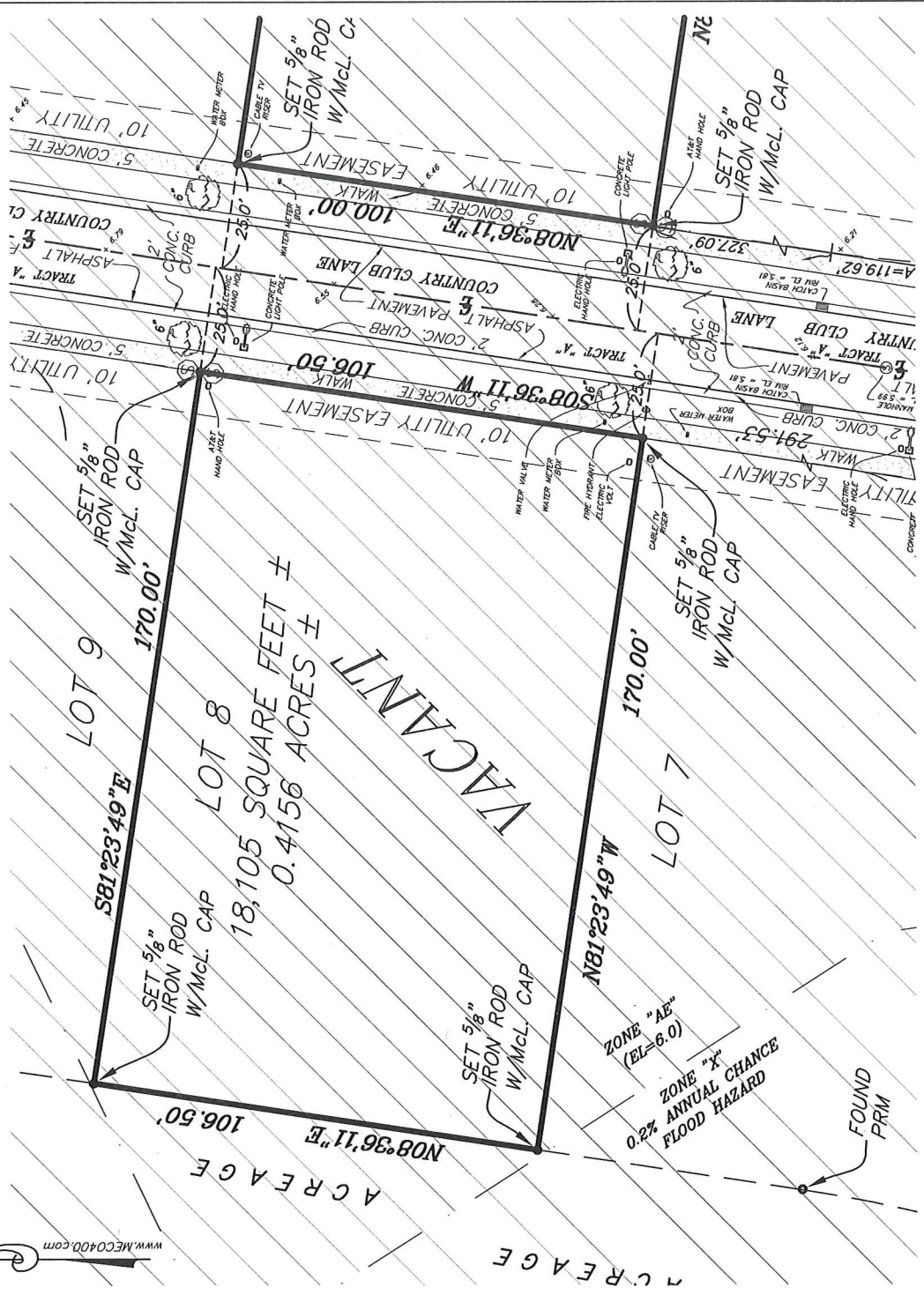
**LEGAL DESCRIPTION**
